Given the provisions on leaving school for children under the age of 14, dictated by Article 19 -bis of Decree-Law October 16, 2017, n. 148, converted, with amendments, in Law of December 4, 2017, n. 172), hereinafter transcribed:

*"Art. 19 - bis"*

- *The parents exercising parental responsibility, guardians and entrusted subjects within the meaning of Law No 184 of 4 May 1983 of children under the age of 14, in view of their age, degree of autonomy and specific context, as part of a process aimed at their self-responsibilization, they may authorise the institutions of the National Education System to allow the independent exit of children under the age of 14 from school premises at the end of class time. The authorisation shall exempt school staff from liability for the fulfilment of the supervisory obligation.*
- *The authorisation to use the school transport service autonomously, granted by the parents exercising parental responsibility, by the guardians and by the entrusted subjects of children under 14 years old to the local authorities managing the service, exemption from liability related to the fulfilment of the obligation of vigilance in the ascent and descent from the vehicle and in the time of the stop used, also on the return from school activities*

**DECLARES**

- a) *to be unable to guarantee the presence of a parent or other adult person delegated upon leaving the school, at the end of the normal lesson time;*
- b) *that the journey from school to home is known to the minor, who has already traveled it independently without accompanying persons;*
- c) *that the minor has been given instructions to return directly and promptly to his or her home;*
- d) *to undertake to inform the school in a timely manner, if the safety conditions change, or the conditions that allow the minor to leave the school unaccompanied have ceased to exist;*
- e) *to exempt, in the case of use of school transport, from the responsibility connected with the fulfillment of the obligation to supervise when getting on and off the vehicle and during the time spent in the proximity of the school building, upon returning from school activities and in the journey from the exit of the school to the school transport, and vice versa; therefore*
